## Management Measures

## No.

Article 1 Chung Yuan University, hereinafter referred to as the school, promotes and promotes the atmosphere of the school and promotes the purpose of promoting wholeperson education

Cultivate students who are interested in various sports, strengthen physical fitness and skills, and represent the school to participate in sports competitions

To achieve good results and win glory for the school, the "Central Plains University Sports Team Guidance and Management Measures" hereinafter referred to as This method.

Article 2 All full-time teachers in the physical education room of the school may apply to the physical education room to form a representative team, which shall be established after being approved by the physical education room office meeting and submitted to the physical education committee of the school for approval.

The establishment of a representative team shall meet the following conditions:

1. Mainly to participate in the sports competitions organized by the Asian Games, the Olympic Games, or the college games, college leagues, and college individual championships.

2. Comply with the expertise of the existing full-time teachers in the physical education room.

3. The school's sports venues and equipment meet the training needs.

4. Priority should be given to the key sports or characteristic development projects of the school.

Article 3 If the representative team is found to have one of the following circumstances by the sports room office meeting, it shall be a representative team for one school year within a time limit:

internal improvement. Those who are unwilling to improve or fail to improve will be dismissed after being approved by the sports room office meeting and sent to the sports committee of the school for approval.

1. The representative team violates the competition regulations of various competitions, and the circumstances are serious.

2. The number of representative teams is insufficient or the venue facilities cannot provide normal training operations.

3. When the representative team does not have a coach with a professional coaching certificate to guide.

4. The representative team has stopped organizing training for more than one school year.

Before the sports room office meeting decides to dissolve, the team members should be given the opportunity to express their opinions, and after the resolution is dissolved, a formal notice with reasons should be attached.

After the representative team is officially disbanded, the rights and interests of the representative team members will continue to be protected.

Article 4 The coaches of the representative team are mainly full-time teachers in the sports room who have the expertise of the sport.

Five coach responsibilities:

1. Establish a representative team training plan.

2. Review the performance of the representative team, and have the authority and responsibility to evaluate whether the members of the representative team will stay or not.

Article 6 The qualifications of team members shall meet one of the following conditions:

1. Entrants with excellent performance in various sports.

2. Once signed up for the college league or college sports meeting on behalf of the school.

Article 7 Rights and interests of team members:

1. Members of the representative team can take the physical education courses of the representative team during the training period, but they must arrive on time to practice in accordance with the practice time of the representative team.

2. Members of the representative team will be given public holidays when they represent the school to participate in external competitions.

Article 8 Obligations of team members:

1. Members of the representative team should attend the training on time according to the training plan. If they are unable to participate in the training in case of any accident, they should contact the coach

Agree and apply for leave according to the procedures stipulated by each team.

2. Members of the representative team must obey the guidance of the coach during

training or competition. disobedience to coaching instructions

Or those who fail to attend the training on time and the circumstances are serious, the coach may suggest to withdraw from the team.

3. Members of the representative team may provide assistance in cooperation with relevant school activities.

Article 9 The withdrawal of team members shall be subject to the approval of the sports room office meeting.

Article 10 Training time:

1. During the semester, it will be implemented according to the time set by the coaches of each representative team.

2. According to the needs of the competition, training can be carried out during the winter and summer vacations.

Article 11 The training location is mainly on-campus grounds, and training can be relocated when necessary.

Article 12 When the representative team participates in off-campus competitions and achieves excellent results, it may be awarded in accordance with the "Central Plains University Sports Scholarship Award"

"Measures" to award certificates or scholarships according to their achievements to encourage their achievements.

Article 13 Matters not covered in these regulations shall be handled in accordance with the relevant regulations of the school.

Article 14 These regulations are approved by the administrative council and reported to the principal for promulgation and implementation, and the same is true for amendments.
